



REQUEST FOR QUOTATION: APPOINTMENT OF A SERVICE PROVIDER TO REPAINT PARKING LINES AT NHBRC PREMISES IN SUNNINGHILL.

INTRODUCTION

1. The National Home Builders Registration Council (NHBRC) seeks to appoint the suitable qualified and experienced service provider to repaint lines in the parking lot.
2. Only service providers who have a **CIDB grading of 1SK or higher** will be considered for appointment.
3. The service provider must **attached four(4) reference letters** of a similar projects.
4. Site visit will be done to confirm the refence letters.

SCOPE OF WORK

1. Paint two handicap signs / disabled signs on two bays.
2. Road marking paint shall complies with SANS 731/1 SABS approved (conforms to Types 1 and 2, Class 1).
3. The service provider must use **ROAD STRIPING MACHINE** to paint.
4. Paint in-bay numbering on all parking bays (**199 bays**).
5. Colour to be used in execution of the work shall be bright White and Yellow.
6. The workmanship warranty must be **five (5) years**.
7. The work must be done on weekends.

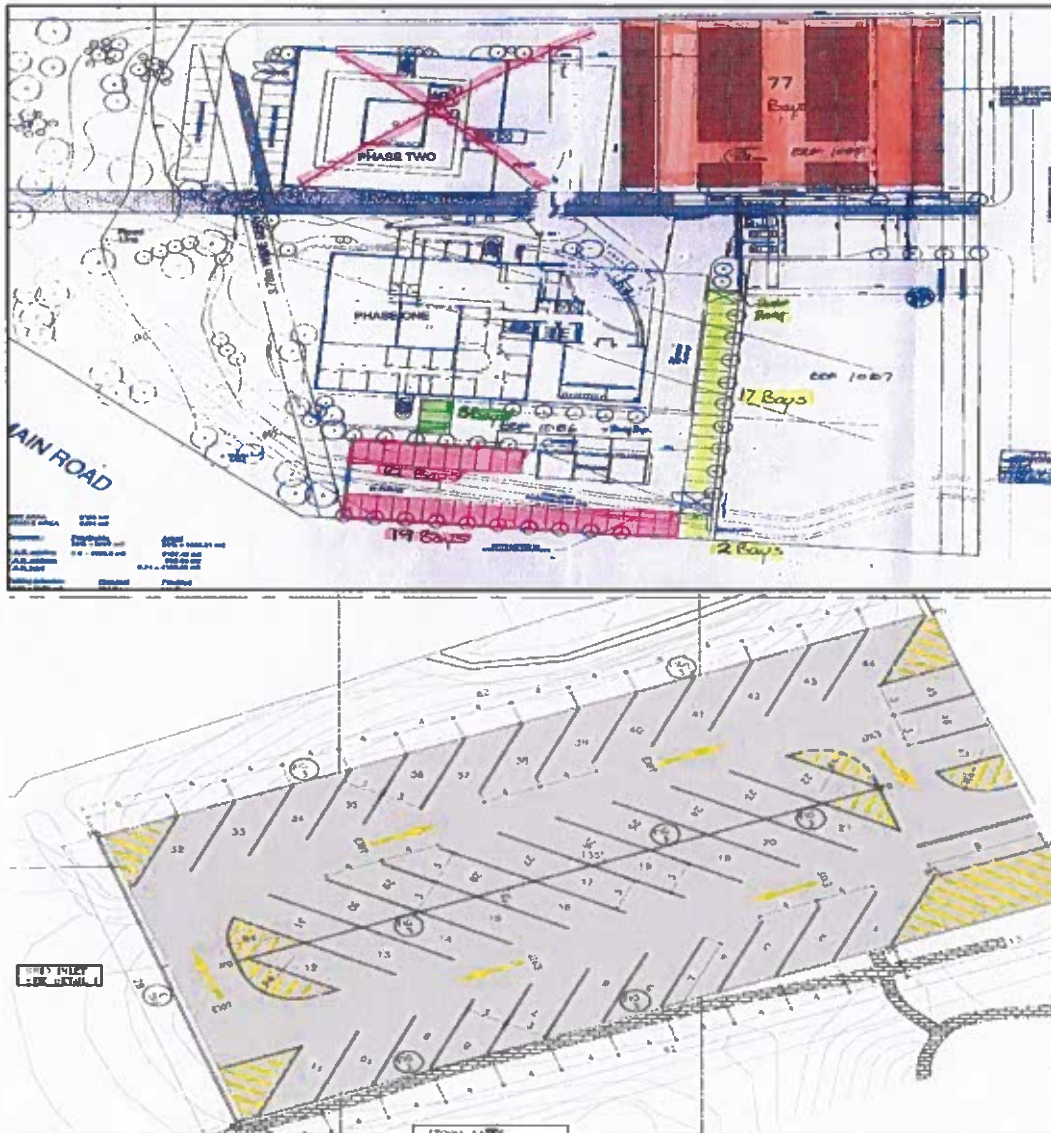
